Textual Information()	NCLT by its order dt. 31-07-2018 approved extinguishment of shares, Reduction of Face Value of Shares to Rs. 0.50 per Share from Rs. 5 Per Share and further consolidation of face value of shares to Re. 5 per share and allotment of shares to resolution applicant. Post these corporate actions paid up equity shares has been reduced from Rs. 20,58,48,335 comprised of 4,11,69,667 shares of Rs. 5/- each to Rs. 2,05,84,835 comprised of 41,16,967 equity shares of Rs. 5/- each. However approval from BSE and NSE is pending hence corporate actions can not be completed with CDSL, NSDL, hence shareholding pattern has been filed as per previous capital structure.
